## 66.19 Climate change.

Cllr Richards has raised this issue in the St John newsletter, confirming the support of the Parish Council should a local group be formed and apply to the Parish Council for financial support.

Cllr Trubody informed the Council of the work being undertaken by Cornwall Council and local initiatives including plans to reforest areas on the Rame peninsula.

Mrs Overton kindly gave the members a resume of the latest initiatives in Cornwall to reduce the carbon footprint, aiming for a carbon neutral County in the future. There is a Climate change workshop in Liskeard on 29<sup>th</sup> February for interested parties to attend. Mrs Overton agreed to keep the Council informed of further developments.

Mrs Overton advised the Council that Ms Wallerstein and Bryony Stokes may request funding for a film project to raise local awareness.

# 67.19. Drainage issue in Church lane.

A work party from St John, identified drainage issues in Church Lane. Cllr Richards contacted Cornwall and Council and W Glassop and Cormac have completed the works.

# 68.19. Clearing leaves and mud from roads.

Cllr Richards informed members that Biffa have the contract to clean up superfluous leaves and mud from the local roads. W Glassop (Cornwall highways) arranged for a clean up exercise to be completed in St John.
