#### St John Parish Council

Minutes of St John Parish Council Meeting on Thursday 30<sup>th</sup> Sept 2021 at 7.30pm St John Village hall.

**Those present**: Mr D Richards (Chairman), Mr R Hoskin (Vice Chairman), Mr H Everard, Mr B Crane, Mr J Tanner, Mrs J Hirst, Cllr Ewert (Cornwall Councillor) and Mrs Allen Clerk to St John Parish Council.

#### 39.21 Apologies for absence. None.

**40.21 Declarations of interest relating to items on the agenda.** Cllr Richards declared that he is a Trustee of St John Village hall.

#### 41.21 The Minutes 20th May and 15th July 2021 were reviewed and approved.

#### 42.21 County Councillor report.

"Double yellow lines at Withnoe Terrace, having been scrubbed out to only have one line – I am investigating with Highways.

Freathy Chalets and Antony Estate, ongoing discontent with the new leases.

Military Rd junction – line of site issues, especially with parking. Hopefully this will be rectified with the proposed speed limit changes and double yellow lines.

Speed limit through St John – would the PC like for the village to be put forward for the 20 is plenty scheme?

Millbrook PC have agreed to a feasibility study on Hounster Hill/West St narrows that will look at potential weight/size limits, if this is the case I would want to push for these across the entire peninsula, I don't want to push the issue up to the cliffs which we know aren't able to take them.

Looe to Cremyl cycle scheme – Roy attended the briefing with Alexis on the project so far, I will let him tell you about the proposals for St John specifically, but I believe they are quite positive.

I have had contact with the owner of Ganges about their planning app for a porch and am meeting with the planning officer on Monday to discuss.

There will be a CNP focus event likely on 11<sup>th</sup> November looking at Health and Social Care in the area, an invite will come out soon.

#### **County Hall**

We have recently been told that Saltash Leisure Centre is under threat of closure, there is a current consultation ongoing that I would encourage members to complete, but also would encourage to PC to complete on behalf of residents as well. Local schools use the pool for swimming lessons, as well as many residents. I do not see that Liskeard Pool would be able to cope with the extra users adequately.

Councillors that supported a motion to full Cornwall Council asking for a housing emergency to be declared were invited to a briefing with the housing portfolio holder regarding the new administrations plans for dealing with the crisis. I'm pleased to report that they are hoping to do everything that we have asked for, including pushing government for better devolution for Cornwall that will allow us to better control 2<sup>nd</sup> homes and holiday lets, build new council housing and enforce existing covenants on ex-RTB council properties. We have been asked to ask PCs if they can identify any potential sites for building Council Houses as well."

It was noted that Maker view 53 has not submitted a new application yet. **Action:** Clerk to follow up.

Cllrs discussed planning application PA21/05788. Members felt that the decision by Cornwall council to approve this application was unwise given the instability of the cliff in this area.

#### 45.21 Policies. None.

The Councillors discussed a proposal made by Cllr Ewert that had been raised at the Maker with Rame environmental forum that the NDP could be amended to approve its green credentials. Members were not receptive to this proposal as the previous plan had taken 7 years. A review could cost between £30,000 - £40,000.

**46.21 Network cluster update.** Cllr Hoskin reported that the police have recruited 12 new police for SE Cornwall. In 2020-21 there were 270,000 999 calls alone to SE Cornwall police. Ambulance attendance times are often up to 4 hours and the police have to stay in situ until the situation is resolved.
