#### St John Parish Council

<u>Draft minutes</u> of The Annual meeting of St. John Parish Council on Thursday 15th May 2025 at 7.30pm at St John Village hall.

**Those present**: Cllr D Richards (Chairman), Cllr Hoskin, Cllr Honey, Cllr Tanner, Cllr Hirst, County Cllr Ewert, 7 members of the public and Mrs Allen Clerk to St John Parish Council.

- **1.25** Apologies for absence. None.
- **2.25** Cllr Hirst proposed Cllr Richards for Chair and Cllr Hoskin for Vice chair of St John Parish Council. Cllr Tanner seconded these proposals. Resolution to appoint Cllr Richards as Chair and Cllr Hoskin as Vice chair to St John Parish Council was approved unanimously by the full PC.
  - **3.25 Declarations of interest relating to items on the agenda.** Cllr Tanner declared an interest in item 4.25d as a resident in Mowhay meadow.
- **4.25 County Councillor report.** Cllr Ewert reported that as it was election year very little had happened in April 2025 as far as the Cornwall Council was concerned. After the election Cornwall Council has no overall majority politically.
  - **4.25 a** 64.24 a Cllr Ewert confirmed The **local car parks** on the Rame peninsular have remained in Cornwall Council control.
  - **4.25 b** 64.24 c Cllr Ewert is following up a continuing **enforcement** issue within the parish.
  - **4.25 c Military road subsidence** is a continuing issue. Cllr Ewert will organise a face to face meeting with Highways and the Parish councils impacted by this. It is important the road is kept open for local businesses and residents.
  - **4.25 d** 64.24 e Unstable Mowhay meadow trees, have been inspected and deemed to be safe. They will be reviewed in 18 months. Cllr Ewert to request that they be pollarded or topped.
  - 5.25 Public forum. None.

**7.25** d 68.24 **20mph sign repair and road marking reinstatement (20mph and humps).** The road signs have been repaired. However the 20mph humps and road painting has been added to a schedule of work by Cornwall highways with no time scale.
